For the purposes of this agreement, the contracting party and the “Person Responsible for Payment” must be one and the same, must be an individual, and will be referred to from here on as the “Client”. For the purposes of this agreement, Memories In Motion Classics and its affiliates will be referred to from here on as the “Company”.

Packages

All Wedding Packages are based on number of destinations. Each Package includes a beautiful vintage car driven by your personal chauffeur, an elegant red carpet leading up to the vehicle, a bottle of champagne at the conclusion of service, a beautiful “Just Married” sign on the back of the vehicle, time to create stunning pictures, and the opportunity to make some amazing memories on your wedding day. Clients may select from 3 distinct Wedding Packages with customized packages available by request.

Classic Package

Enjoy the beauty of riding in classic style on your wedding day. Package includes transportation to **ONE** destination such as from your ceremony location to your reception or from your reception to your local hotel and up to a maximum of 2 consecutive hours of service.

Elegant Package

****Our Most Popular Package****
For couples that want to enjoy pure elegance on their wedding day. Package includes transportation to **TWO** destinations – such as from your ceremony to your reception and then as a “get away” car from your reception to your local hotel and up to a maximum of 5 consecutive hours of service.

Platinum Package

When nothing but the finest will do on your wedding day. Our Platinum Package offers service throughout your wedding day with **THREE** destinations - Transportation to your ceremony site, from your ceremony site to your reception, and then away from your reception to your local hotel and up to a maximum of 8 consecutive hours of service.

Client is contracting with Company for the above service. A 50% non-refundable deposit per vehicle is required from the Client along with the signed contract to secure Client’s desired date. The remaining balance must be received 15 days prior to the day of the event. All payments must come directly from the Client and may be in the form of cash, check, money order, or credit card. For Client’s convenience, Chauffeur Gratuity can be automatically applied at time of booking and prepaid as part of balance. Chauffeur Gratuity of 10-20% is common in the livery industry. Service outside of Auburn/Opelika, AL will incur an additional Destination Fee for travel costs to Client’s location. This quoted fee is applicable for 30 days after which this fee is subject to change. Any adjustments will be made 30 days prior to wedding date. Package time begins at the contracted Initial Pickup Time and ends upon couples exit of the vehicle at their final destination. Time used beyond what is contracted before the wedding date will be billed in 1 hour increments to the credit card on file at the time of service for the overtime rate of \$150/hour. Client **must** provide a credit card to remain on file to be used in the event of time overages or damages. Client authorizes the Company to charge card on file for any and all damages and time overages without prior written notice. A summary of these additional charges will be sent within 5 business days of the event date. Client, Bride, and Groom grant the Company the irrevocable and unrestricted right to use and publish photographs taken during their contracted time for editorial, trade, advertising, and any other purpose and in any manner and medium without restriction and without their inspection or approval.

Bird Seed & Sparklers

The use of sparklers and birdseed is welcomed however it **MUST** be disclosed in the above Special Instructions section of the contract. Client **MUST** insure that Guests with sparklers or throwing bird seed **maintain a minimum distance of 15ft from the vehicle at all times** and no birdseed will be thrown in the direction of the vehicle. Client agrees to take full financial responsibility for any and all damage caused by Guests with sparklers. These requirements are for the safety of the guests, the Bride and Groom, as well as our drivers and vehicles. Any damage incurred by the failure to do so will be subject to the below "Damages" clause.

Liability

Client is contracting with Company for the above service. It must be recognized that the vehicle(s) provided are both highly unique and antique in nature. Client therefore authorizes and approves the Company substituting the "preferred" vehicle for another vintage vehicle of any make/model at any time without prior notice in the very unlikely event of mechanical breakdown in order to provide the contracted service. Client further agrees that no recourse will be sought and no refund will be issued if Company supplies any portion of the contracted service and any vintage vehicle is provided. Full/partial refund and the amount will be issued at the discretion of the Company if the Company is completely unable to provide the contracted service due to weather, mechanical breakdown, or other event preventing Company from providing the contracted service. Client understands and agrees to the aforementioned statement and further agrees to hold harmless the Company and any of its affiliates. Client understands that in order to provide the widest variety and highest quality of unique and antique vehicles, the Company may contract with independent owner-operators. As a result, package price and amenities are subject to change without prior notice. While we make every effort to locate and return articles that are left behind, neither the Company nor its affiliates are responsible for items left in the vehicle.

Damages

Client (Person(s) responsible for payment) assumes full financial responsibility for and subsequent payment of any and all damages to vehicle incurred by their guests during the contracted period. Client must provide a credit card to remain on file and authorizes its use for any and all charges made by the Company without prior notice. A summary of these additional charges will be mailed to the Client within 5 business days of the event date. Due to the highly unique and antique nature of the provided vehicles, the minimum damage charge will be \$500 and all damage costs are non-negotiable and non-disputable. The presence of beverages of any kind is strictly forbidden inside the vehicles. The release of any bodily fluids while in the vehicle will result in an automatic \$1,000 minimum charge. Failure to remit damage payment will result in immediate legal action. Client agrees that the Company and any of its contracted owners will be in no way held liable for any personal injury or property damage of any kind while vehicle is being used under contract. Clients agree to comply with all federal, state, and local laws.
